• 1945 November 05

 Application for Post of The American Legion received by The American Legion National Headquarters Indianapolis, Indiana

• 1945 November 14

National Adjutant Donald G. Glascoff requested reassignment of Post 55 to Post 41. Number 41 was the Captain John Henry Allen Post of Fort Huachuca and was canceled in 1941.

• 1945 November 23

 Organizational Meeting hosted by and at The American Legion Post 1. Election of temporary officers; Commander, Carlos Ontiveros; First Vice Commander, Pete Martinez; Adjutant and Finance Officer, Abe Norriega. All sworn in and first meeting was held.

• 1946

- League of United Latin American Citizens (LULAC) Council 110 approached The American Legion Post 41 Commander Ray Martinez and invited them to join them in the effort to change the over 20-year-old policy of "No Mexican's Allowed".*1
- May 21, 1946 Tempe Chamber of Commerce meeting agreed to drop the "No Mexicans Allowed" sign.

• 1946

- Commander Ray Martinez additionally, in a City of Phoenix Council meeting, refused to accept the segregation of Hispanics in the proposed 124 housing unit at 16th Street and Henshaw (Buckeye) Road, the site of an old dump. Opposed to integration was led by Eddie Poole, head of the Garfield Property Owners Protective Association.
- o July 6, 1946, Mayor Ray Busey and the City council voted to integrate the housing (Mexican and Anglo only), providing 24 of the units to Mexican Americans.

• 1947 April 02

Lease No. 1631 approved by the City of Phoenix for the sum of one dollar a year for fifty years.
 Signed by Commander Ray Martinez, renew April 2, 1997. Includes from Plat of Block 12 – Montgomery Addition, Lots 4, 5, 6, 7, 8, and 9 and the west 80 feet of Lots 10, 11, and 12. (Does not include land that the Duppa/Montgomery Adobe building, remainder of Lots 10, 11 and 12.

• 1947 July 26

Members began to break ground and volunteered their labor during their spare time after work.

1948 January 15

o The American Legion Women's Auxiliary Unit 41 applied for its charter. It was approved and presented on April 1, 1948.

• 1948 January 30

o Rebecca Valenzuela called the first meeting of The American Legion Unit 41.

• 1948 March 14

 The American Legion Thunderbird Post 41 held a dedication ceremony opening the doors of the newly built post home.

• 1948 March 29

Received a Certificate of Incorporation from the State of Arizona Corporation Commission, Docket
 172 Page 454, filed by Commander Ray Martinez and his administration.

Post 41 Commander Martinez successfully confronted the Stewart Construction Company on behalf
of Post member Donald Gaylien. The company denied Gaylien's and other Hispanic's loan
applications. By the 1950's the area was integrated.

1950 - 1951

 Ray Martinez, Post 41 Past Commander elected to be The American Legion Department of Arizona first Hispanic State Commander.

1953 January 09

Lease No. 2612 approved by City of Phoenix for the sum of one dollar (\$1.00) per year for forty-two years (1994) includes East 124 feet of Lots 13, 14, 15; Lot 16 and south 20 feet of Lot 17; all in Block 12. (Parking lot and South of Adobe Building. As of 16 December 1952, to 2 April 1997. Signed by Commander Manuel Yanez.

• 1954 February 15

 Sub-Lease of 1631, designation of lease changed to No. 1382, includes fifty (50) foot of the south ten (10) feet of Lot 9, signed by Commander Raymond Stokes.

• 1954 February 15

o Sub-Lease of 2612, designation of lease changed to No. 1382, effectively combining Lease 1631 and Lease 2612; building and parking area. Signed by Raymond Stokes.

• 1956 April 03

Lease No. 2612 extension of Section 8 completion of building hall to include kitchen to be completed by February 27, 1956, to February 27, 1961 (five (5) year extension, total of ten (10) years). Signed by Commander Frank "Pipa" Fuentes.

• 1963 September 15

 First Annual Americanism Queen Coronation was held under the administration of Commander Florencio Othon

• 1965

Revision of the Constitution and By-Laws of Thunderbird Post No. 41 were published

1966 February 28

o Post 41 received Charter for Troop 119 in the Boy Scouts of America.

• 1968 - 1969

 Tony F. Soza, Post 41 Past Commander elected to be The American Legion Department of Arizona second Hispanic State Commander.

• 1971 February 09

Tony F. Soza name is added to Post 41, after his passing on August 26, 1970, at the age of fifty-one
 (51) of a heart attack. Charter name change submitted by Commander Gilbert Jacques.

Timeline Summary

• 1981

 Scholarship funds established to be presented to students graduating from Grammar School entering High School, intended to assist with school supplies. Dedicated funds were included in Frank "Pipa" Fuentes's Last Will and Testament dated March 23, 1981. Students are submitted by five community schools. Five scholarships are awarded each year.

 Marco A. "Tony" Valenzuela Post 41 Past Commander elected to be The American Legion Department of Arizona State Commander and forth Post 41 member to be elected.

• 1991 August 30

 Post 41 host events for the 73rd National American Legion Convention, Commander David Coronado.

• 1992 February 19

o The American Legion Post 41 filed with the Arizona Corporation Commission the Articles of Incorporation. The articles were approved and filed on February 21, 1992.

• 1992 August 27

Lease No. 1631 Extension approved by City of Phoenix from April 3, 1997; through March 31, 2012, signed Commander John Aldecoa. (Original Lease 1947 April 2).

o The American Legion Post 41 home celebrated its 50th Anniversary.

 The Honorable Ed Pastor entered within Congressional Record, E2075, a statement honoring The American Legion Tony F. Soza Post 41accomplishments.
